4) Observation of visitor behaviour

[Generationgreen.energy](https://generationgreen.energy) uses various techniques to keep track of who visits the website, how visitors behave on the website and which pages are visited. This is a common practice for websites because it provides information about the quality of the user experience. The information we collect via cookies includes IP addresses, the type of browser and the pages visited. We also record where visitors first visit the website and from which page they leave the website. This information remains anonymous and is not linked to other personal data.

5) Use of Cookies

[Generationgreen.energy](https://generationgreen.energy) places cookies on visitors. We do this to collect information about which pages users visit on our website, to keep track of how often visitors return and then to determine which pages on the website are well received. We also keep track of what information the browser shares.

6) Deactivating cookies

You have the option of deactivating cookies. You can do this via your browser settings. Further information on this can be found on the website of your browser provider.

7) Cookies from third-party providers

It is possible that third-party providers, such as Google, may place adverts or use other services on our website. In some cases, these third-party providers may use cookies for this purpose. These cookies have no influence on generationgreen.energy.

8) Our advertising partners

Adverts are placed on generationgreen.energy by various parties, which all place their own cookies. These advertisers use technologies and links for their ads that are recognised directly by your browser. Among other things, they use automatic recognition of IP addresses that are sent directly to the advertiser.

In addition, cookies, Javascript and possibly web beacons are used to monitor the effectiveness of the campaigns of these providers. Generationgreen.energy has no influence or control over the cookies, javascript and web beacons of our advertising partners.
